25 and then I think it was Adam doesn't want me
26 to talk about it, or Adam's not prepared to talk about it
27 unless he says it's O.K.

31 I don't wanna talk about it.

2 MS GOBBO: And also, that was back at a time when I was trying
3 to actually not tell you things that were privileged, but
4 I've woke up to that now, so - - -

5

6 Sandy White-O Is that - is that - is that - - -

7

8 Green-O Actually can be privileged?

9

10 MS GOBBO: Of course it is, why isn't it? Why isn't any -
11 like, when I sit here and say to you, "This is exactly
12 what [REDACTED] will do, this is what he'll say to
13 you," I mean all of what his communication - well, mine
14 with him, is privilege, but I'm way past that now.

15

16 Sandy White-O Mm.

17

18 MS GOBBO: Long past that.

19

20 Sandy White-O But if Adam gave you instruction not to talk
21 about, say, Dublin Street - - -

22

23 MS GOBBO: Yep.

24

25 Sandy White-O - - - is that - is that - - -

26

27 Green-O not break.

28

29 MS GOBBO: Yep.

30

31 Green-O Yeah, you could?

2 MS GOBBO: I can't break it.

3

Green-O

4 : No?

5

Sandy White-O

6 | : Is that - that's in relation to anything he did.

7 Is there - like, if he - - -

8

9 MS GOBBO: No

10

Sandy White-O

11 : They're not instructions for his defence though,

12 are they?

13

Green-O

14 : But his - - -

15

16 MS GOBBO: No, but it's confidential communication, that's why

17 you call out a lawyer. Why have - what permits me to be

18 able to talk to anyone about it, particularly police?

19

20 | Does it - well, why I - I don't wanna

21 wrong, but I thought that the privilege extended as far

22 as instructions relevant to his defence.

23

24 MS GOBBO: Yes.

25

Sandy White-O

26 : If you had conversations outside of that, are

27 they necessarily

28

29 MS GOBBO: No, in the course - if it's in the course of the

30 confidential relationship or it's in the purposes of what

31 may be litigation later on, whether it's criminal or

1 civil or whatever, yeah, you're not privilege.

3 But not every conversation you have with Adam
4 would be privileged, would it?

5

6 MS GOBBO: No, no, not at all.

7

Sandy White-O

8 So - so say for example there was, like, I don't
9 know the facts particularly, but say there was 10,000
10 tablets in the house - - -

11

12 MS GOBBO: Yep.

13

Sandy White-O

14 - - - and Adam's caught in the house, bang. If
15 it turns out there was 20,000 tablets thrown over the
16 back fence - - -

17

18 MS GOBBO: Yep.

19

Sandy White-O

20 - - - or something that he didn't - didn't
21 particularly relate to him or he didn't know anything
22 about, although it has since - - -

23

24 MS GOBBO: Try 200, but, yeah, go on.

25

Sandy White-O

26 Yeah, well - yeah. Then, is that a part of the
27 privilege conversation, where the only matters that
28 concern Adam are really the 10,000 found in the house,
29 but the - the 200,000 over the back fence?

30

31 MS GOBBO: Not, that's all part of the same - - -

4 MS GOBBO: Yep.

O.K. In answer to your question, the interest -
