**Good Work Performed During Operation "YAK"**

I have been informed that, recently, whilst you were performing duties with the "A" District, District Support Group, that you played an integral part in the successful conclusion of Operation "YAK".

Operation "YAK" was an Operation conducted by members of the "A" District, District Support Group between 19 August and 3 September, 1993, which involved lengthy periods of intense surveillance and intelligence gathering regarding the activities of an alleged drug trafficker in the Carlton Sub-District.

Operation "YAK" was successfully concluded on 3 September, 1993, with the arrests of Brian WILSON, Nicola GOBBO and Victor VELLIOS. All were charged with Traffic Drug of Dependence (Cannabis and Amphetamines) and Unlawful Possession. I note that this Operation resulted in the seizure of 3 pounds of Amphetamines with a street value of \$82,000.00, 3/4 of a pound of Cannabis with a street value of \$3,000.00, in addition to the seizure of a large quantity of stolen property and a number of Prescribed Weapons.

I would like to take this opportunity to extend my congratulations for a job well done. It is obvious that the professionalism and dedication to duty displayed by all those involved contributed in no small way to the excellent results that were achieved.

It is also obvious to me that these excellent results are indicative of the fine "team spirit" that has developed within "A" District Support Group.

Once again, my congratulations. All other members of "A" District Support Group involved in Operation "YAK" have been congratulated in a similar fashion. I will ensure that a copy of this letter is inserted in your Record of Service and that an appropriate entry is made in the "A" District "Good Work" Register.

CIRCUMSTANCES

2. Following receipt of information via crime stoppers, operation "Yak" was conceived with a view of gathering evidence relating to drug activity against Brian WILSON of 250 Rathdowne Street, Carlton.
3. After intense surveillance of the suspect and his premises, a search was carried out on his premises on the 3rd September, 1993. Several arrests were made and property including substantial amounts of drugs were seized. (refer folios 1 & 2)

COMMENT

4. This type of good work is indicative of the work performance of the "A" District D.S.G. members.

RECOMMENDATION

5. Accordingly, I recommend the following:-
  - (a) that Sergeant's ASHTON 21889, HOLDING 20985, Senior Constable DELANEY 26707, Constable's FREDE 26856, SKLAVOUNOS 27066, WILSON 28319, TRICHIAS 27066 and RANDOE 28470 be commended at District Level for dedication to duty, and professionalism in the investigation and apprehension of an active drug dealer.

**BRIEFING PAPER**

On the 19th of August, 1993, a file was received at this office via Crime Stoppers in relation to a suspect, Brian WILSON of 250 Rathdowne Street, Carlton, who was allegedly selling amphetamines in large quantities and was in possession of an automatic pistol.

It was ascertained Brian WILSON (07/02/66), IBR HW1768, holds a security guard and crowd controller's licence and is also the holder of a shooters licence, owning longarms. WILSON was also ascertained to be residing with Nicola Maree GOBBO (16/11/72), who also allegedly assisted WILSON with selling the amphetamines.

Mobile surveillance was conducted on the target WILSON and also of GOBBO. Both were seen to often use mobile telephones whilst driving. On the 27th of August, 1993, whilst under mobile surveillance, the target was observed to perform a possible drug transaction with another male from the target's vehicle, in the Richmond area. Other suspicious activity was observed on several other occasions, for example, the target entering a premises with a bag and remaining for only several minutes before leaving.

A search warrant was obtained for the premises on 26th of August, 1993. Surveillance continued on the premises to ascertain an appropriate time to execute the warrant.

On the 3rd of September, 1993, surveillance was commenced on the target premises at approximately 1100 hrs with the intention of executing the warrant at some time that day. At approximately 1200 hrs, the target, WILSON, was dogged from his premises, to Richmond and back through Fitzroy, where he was lost due to heavy traffic. Surveillance was then conducted on his home pending his arrival for execution of the warrant.

WILSON arrived home at approximately 1630 hrs. At approximately 1730 hrs, the search warrant was executed successfully and peacefully, as the target came outside from the premises. He was taken into custody and the warrant was executed. A second male, Victor VELIOS (26/09/59) of 55 Pender St, Preston, was also at the premises and taken into custody. At this time, GOBBO was working at Melbourne University.

At approximately 1900 hrs, Sergeant HOLDING and Constable SKLAVOUNOS left the premises to collect GOBBO from the university. She returned to the premises at 1930 hrs and was taken into custody.
