Thanks for your time on the phone earlier. As spoken about we are part of the Landow Task Force which is running in conjunction with the Royal Commission. Predominately we are looking at the registering of Human Source 3838 as an informer by Victoria Police.

Our investigations have revealed that in 1995 yourself and Tim ARGALL registered 3838 as an informer. 3838 was allocated the registered code G3/95. Both yourself and ARGALL were at the 'A' DSG office at that time, perhaps out of Russell Street. This is the first known time that 3838 was registered as an 'informer'.

We have spoken to D/S/Sgt ARGALL regarding his memories of 3838 at that time. Tim has provided us with certain details regarding his initial meetings and ongoing meetings with 3838. Tim is attempting to locate his diaries/daybooks regarding this period of registration.

- Seconded from Richmond Police Station to 'A' District DSG from September 1993 to 1997, with a small break in between
- From 02/12/1994 15/05/1995 returned to Richmond, before then being seconded back to the DSG
- Back at DSG from 15/05/1995 24/04/1997
- OIC of DSG at time was Brian RIX / Paul BRIGHAM
- Recounted memory of being involved in drugs search warrant at 3838's address in Carlton on 04/09/1993. Target was 3838's boyfriend (or housemate) – surname WILSON
- Attended warrant to assist another crew, led by Sgt Mick HOLDING. Informant for this search warrant Peter TRICHIAS – current Knox LAC
- Recalled that he located a small amount of amphetamines in 3838's bedroom and had a conversation with her. He was then directed to the laundry where approx. 2kg of amphetamines was located
- Other members on his crew were Jeff POPE, Neal THOMPSON, DELANEY, Tim ARGALL and Rod ARTHUR
- Showed HS registration document and confirmed it was his handwriting. Doesn't remember registering 3838. Registration reference relates to July 1997
- Can't recall why 3838 was registered by him some 18 months after his last contact (during search warrant)
- Stated no relationship or any further contact with 3838 after the execution of the search warrant
- Discussed our conversation with ARGALL and his memory of meeting with ASHTON,
 ARGALL and 3838 at MCG when working the football one weekend

- Agreed this occurred, as this prompted his memory. It 'was just a meeting at the footy to have a chat'
- Remembered he saw her a couple of times at the footy. Checked his diary and found
 2 X references to working at the footy 09/07/95 & 23/07/95

- Couldn't remember whether he bumped into her at football or it was a safe haven for having a conversation
- Agreed with ARGALL's version that they both met 3838 high up in the stand
- Doesn't recall any involvement with a UCU assessment by Controller as was detailed by ARGALL
- Nominated other members on his crew at A DSG:
