- 2. My only personal knowledge of Ms. Nicole GOBBO is that whilst I was attached to the Drug Squad at the request of then Detective Senior Sergeant Wayne STRAWHORN I accompanied him to a coffee shop near our workplace at 412 St. Kilda Road, Melbourne and had a coffee with her. I am not aware of whether STRAWHORN or GOBBO instigated this meeting. I don't recall any specific reason why STRAWHORN requested/invited me to attend the meeting, however I assume he wanted corroboration and/or a second person

present. Prior to this meeting I had never met or spoken to Ms. GOBBO, and I haven't met or spoken to her since. My recollection is that the meeting may have gone for between 15 minutes to 30 minutes and there was just the three of us present. I have no recollection of what was specifically discussed, however I distinctly recall it was unremarkable, and as far as I was concerned was of no interest to myself or the Drug Squad. I am certain that Ms. GOBBO did not provide any information about criminal activities of her clients or any other person, and there was no discussion about Ms. GOBBO providing information or of her being a human source. I do recall that STRAWHORN thought she may be a useful contact in the legal fraternity, however I didn't take that to extend to providing information about clients and /or criminal activities. I had no knowledge of Ms. GOBBO providing information, or being involved in any way with investigations conducted by the Drug Squad (or any other area of the Victoria Police). I have been provided with a redacted copy of what I believe is my Police Diary for this period of time and in June 2000 I have made an entry at 1410 (day/date redacted) "Strawhorn meeting Gobbo (solicitor)". I believe this is probably the date I met GOBBO with STRAWHORN, however I have not had access to my Police Diary to fully check the entries between 1998 and 2002.

#### Use of Ms. Gobbo as a human source

- 3. The first time I heard that Ms. GOBBO had been providing information to the police was after the media publicity identified the matter, I believe that was in the latter part of 2018. I don't recall specifically whether someone told me that Ms. GOBBO was the subject of the media articles or whether I first found out once she was identified in the media.
- 4. I had no knowledge that Ms. GOBBO was providing information to the Victoria Police until 2018. Whilst I was attached to the Drug Squad I had no knowledge that Ms. GOBBO was a human source or regular contact of any member of the Victoria Police (other than what I have outlined in paragraph 2).
- 5. I have no knowledge of person(s) involved in the authorization, and/or continued authorization of Ms. GOBBO as a human source.
- 6. As outlined in paragraph 2 the only time I have met or spoken to Ms. GOBBO was when I accompanied Detective Senior Constable STRAWHORN to meet with Ms. GOBBO at a coffee shop near 412 St. Kilda Road, Melbourne. I have not met or spoken to Ms. GOBBO since that meeting. As a result of that meeting it appears I made an entry in my police diary in June 2000 as previously referred to in paragraph 2. I don't recall completing any other documentation in relation to this meeting. Whilst I don't recall whether an Information Report was submitted, it is possible that STRAWHORN may have submitted an Information

Report. If Ms GOBBO was a registered human source at that time STRAWHORN should have submitted an Information Report. I have no recollection whatsoever of ever seeing an application(s) to register Ms. GOBBO as an informer/human source.

- 7. I have no knowledge of Victoria Police receiving any information from Ms. GOBBO in relation to criminal activities or the activities of her clients.
- 8. I have no knowledge of the Victoria Police receiving any assistance by Ms. GOBBO.

### Concerns in relation to use of Ms. Gobbo as a human source

- 9. I had no knowledge or awareness of Ms. GOBBO being used as a human source until the media publicity in 2018. I have never become aware or had concerns raised to me by any members of the Victoria Police or other partners/stakeholders about the use of Ms. GOBBO or any other legal practitioner as a human source, or provider of assistance and/or information.
- I am not aware of any concerns being raised within the Victoria Police about the use of Ms. GOBBO as a human source.
- 11. I am not aware of, and have never been a party to any discussion within the Victoria Police about the obligation of disclosure relating to Ms. GOBBO.

#### **Other relevant matters**

- 12. I have no knowledge of any other human source utilized that had legal obligations of confidentiality or privilege.
- 13. I believe we received training as Police Recruits in relation to the right to of an accused to silence, the right of an accused to have legal a legal practitioner, legal professional privilege, and professional and ethical decision making. I believe this training was reinforced at Detective Training School, Advanced Detective Training School and Sub Officers' Course and at these latter courses included disclosure and public interest immunity.
- 14. In 2001 I reviewed incomplete briefs of evidence against Tony MOKBEL and Carl WILLIAMS (and possibly associates) to determine whether charges should proceed following the arrest of Drug Squad investigators involved in these investigations. I was tasked to undertake this review by then Assistant Commissioner George DAVIS. In undertaking this review I UNCLASSIFIED

had access to a range of documents provided by investigators. At no time during this review did I identify, or have any inclination that Ms. GOBBO may have assisted investigators. I believe this investigation/review came under the banner of of Operation or Task Force KAYAK. At the conclusion of the review I submitted a report outlining my findings. I believe the report was forwarded to then Detective Superintendent NEWTON. I was not directly responsible for Operation/Task Force KAYAK as it was conducted by Unit 2 of the Drug Squad (whereas I was in charge of Unit 1), and was not openly discussed. However in the absence of the Detective Inspector from Unit 2, I sometimes inherited some administrative functions, and had a broad understanding of the status of the investigation. I have been provided with a redacted copy of what I believe is my Police Diary for this period of time and in August 2001 I have made several entries indicating I had been undertaking a review of Task Force Kayak.
