## STATEMENT OF CHARLIE BEZZINA

- 1. My full name is Charlie Bezzina. I am a retired member of Victoria Police.
- 2. I make this statement in response to a request from the Royal Commission into the Management of Police Informants dated 19 March 2019. This statement is produced to the Royal Commission in response to a Notice to Produce.

#### Educational background and employment history (question 1)

- 3. I was a member of Victoria Police for 38 years.
- 4. I graduated from the Police Academy in 1973 and was then located at Russell Street Headquarters as a Constable undertaking general duties. A summary of my employment history since that time is set out below:
  - In 1974, I was a Constable at the Footscray Police Station. I was then promoted to Senior Constable and transferred to the Footscray Criminal Investigation Branch;
  - Between 1983 and 1985, I was located at the Altona North and Maidstone Police Stations and held the rank of Sergeant;
  - In 1985, I was promoted to Detective Sergeant and I transferred to the Bureau of Internal Investigations where I was in charge of the Covert Surveillance Unit for approximately 11 months;
  - Between 1986 and 1989, I was Detective Sergeant Team Leader, in the Drug Squad;
  - In 1989, I transferred to the Homicide Squad and worked there until 1995;
  - In 1995, I transferred to the western suburbs as a Senior Sergeant and was upgraded to Inspector at times;
  - In mid-1996, I returned to the Homicide Squad as a Detective Senior Sergeant and remained there for 11 years;
  - In 2007, I was moved to the *Purana Taskforce*. I was there for no more than a week before taking extended leave;



- In 2009, I transferred to the '*Embona Taskforce*' addressing major issues with armed robbery;
- I retired from Victoria Police in December 2009.
- 5. The professional awards that I have received include the following:
  - (a) National Police Service Medal;
  - (b) Victoria Police Service Medal;
  - (c) Three Commendations for outstanding work;
  - (d) Blue Ribbon Medal.
- 6. I am currently undertaking various consulting roles outside of Victoria Police.

# Involvement or association with any investigation which had dealings with Ms Gobbo (q 2)

- 7. The only investigation that I was involved in that, to my knowledge, had dealings with Ms Gobbo was the investigation into the murders of Terrence and Christine Hodson. I was the Senior Sergeant in the Homicide Squad who was on-call the night that the Hodsons were murdered on 16 May 2004. I went to the scene. I then had carriage of the murder investigation for some time.
- As part of the investigation, on 1 July 2004, Detective Senior Constable Cameron Davey and I interviewed Ms Gobbo as a potential witness. This interview took place at the St Kilda Road Police Station.
- 9. I cannot now recall why Ms Gobbo was identified as a potential witness. I have a faint memory that it may have been because of an association with Tony Mokbel. I cannot recall what was discussed during the interview but I recall that Ms Gobbo did not provide any information of value to my investigation.
- 10. I did not have any further dealings with Ms Gobbo in relation to the Hodson murders.

- 15. The only other occasion on which I can recall having contact with Ms Gobbo was when she was in the presence of Mick Gatto. As I was leaving the Melbourne Magistrates' Court, Gatto was driving past and pulled over to speak to me. Ms Gobbo was with him in his car. I briefly spoke to Gatto while they were sitting in the car. I did not speak to Ms Gobbo directly. I cannot recall when this occurred.
- 16. I recall attending a social function at Crockett Chambers in Lonsdale Street on one occasion. I recall speaking to barristers Terry Forrest (now judge), Robert Richter, Phil Cummins (now retired judge) and others. I have no memory of seeing Ms Gobbo at that function but she may have been in attendance.
