Dear Ms. Jones,

I have again found it necessary that I make contact you; I have a further complaint in regards to Legal Counsel Ms.Nicola Gobbo, **File No. LSC/06/3970**

I am charged with the murder of [REDACTED] & myself, [REDACTED] was granted Indemnity against Prosecution [REDACTED] & myself.

Ms.Nicola Gobbo has represented [REDACTED] at one time or another, she was representing [REDACTED] when he decided to give evidence for the Prosecution, she acknowledged that in [REDACTED] given evidence for the prosecution, that she did have a conflict of Interest, but with her knowing that, she continued to act for [REDACTED] either on record or behind the scene, & would come to [REDACTED] Prison and still visit [REDACTED] & Myself, she had been warned from The Honourable Justice Betty King that she had a Conflict if interest in this matter, after being warned about her conflict of Interest, she continued to give advice to [REDACTED] & I would on occasions speak to her about Legally confidential stuff, [REDACTED] only recently decided to give evidence for the Prosecution against me in this matter, Ms.Nicola Gobbo was going to do [REDACTED] Plea, until I raised my concerns to The Honourable Justice Betty King, in which she fully agreed with me, My legally Counsel told Ms.Nicola Gobbo of her conflict, & she withdrew from acting for [REDACTED] [REDACTED] has no outstanding Court matters besides this one, there is no reason for [REDACTED] to have any contact with Ms. Nicola Gobbo, either by the way of telephone or Legal Visits [REDACTED] at the [REDACTED] Prison, Yet again she was [REDACTED] visiting [REDACTED] again on SUNDAY the 3rd of September, with [REDACTED] who is [REDACTED] current Solicitor, I have serious concerns about this unethical behaviour & I would like it to be stopped ASAP.

I know for a fact that Ms.Nicola Gobbo, has done work behind the scene for [REDACTED] in this matter, when she did have a conflict of interest, as [REDACTED] & [REDACTED] Prison, and [REDACTED] also both [REDACTED] & Ms.Gobbo have directly told me of this, my concerns are if Ms.Gobbo, can act unethical in regards to her conflict of interest, after her being told on numerous occasion about it, then I believe that she of course act unethical in regards to myself, and tell [REDACTED] about the Legal Confidential stuff that I have spoken to her about , I don't need these headaches, & it is my belief that a person in her position should act A LOT BETTER than what she currently does.

My claims that Ms Gobbo has acted unethical when she was told there was a conflict of Interest, & continued to work & prepare for [REDACTED] case, can & will be supported by telephone intercept material between Ms.Gobbo & [REDACTED] which are at the [REDACTED] Prison, I know this for a fact that Legal calls are recorded, as I recently subpoenaed all call made by [REDACTED] but I wasn't permitted access to his legal calls, as they claimed privilege, yet Ms. Gobbo was not on record as being [REDACTED] Barrister , so I don't understand what could be privileged

I look forward to your response in this matter, in writing, at your earliest convenient time.
