## Complaint

The Legal Services Commissioner requested the Ethics Committee pursuant to an instrument of referral to investigate the disciplinary complaint.

The Ethics Committee considered that Mr. Williams makes complaint that Ms. Gobbo had a conflict of interest in regard to her representing a continues. It is alleged Ms. Gobbo continues to keep in regular contact with the by way of telephone, contact visits and appeared on his behalf at his arraignment.

### Investigation

The Committee resolved that pursuant to s.4.4.11(1) of the Legal Profession Act 2004 Ms. Gobbo provide a full written explanation of her conduct and any other information or documents.

By letter dated 25 September 2006 Ms. Gobbo provided her response.

By file note dated 25 September 2006 Ms. Gobbo provided further comment.

# Result of investigation

Having considered Ms. Gobbo's responses the Committee consider the Legal Services Commissioner dismiss the disciplinary complaint under s.4.2.10(1)(b) as misconceived and lacking in substance.

#### Ethics Committee's Reasons:

The reason why the Committee was satisfied that the complaint was misconceived and lacking in substance was that, on the material provided, the Committee considered that the matters the subject of Mr. Williams complaint do not raise any ethical issues to suggest that Ms. Gobbo acted unethically or unprofessionally. In particular, Ms. Gobbo is not acting as counsel for as alleged in the complaint.

Accordingly, the Committee considered that the matters referred to in this complaint raised no conduct issues which required disciplinary proceedings.

#### Recommendation

Pursuant to s.4.4.13(6) of the Act the Legal Services Commissioner adopt the Ethics Committee's recommendation and dismiss this complaint under s.4.2.10.(1)(b) of the Act.
