

Engaging in legal practice outside the scope of the conditions on your practising certificate is a ground for amending, suspending or cancelling a local practising certificate, and may also warrant disciplinary and/or compliance action.

If you are authorised to engage in legal practice as a principal or employee of a law practice, or as a corporate legal practitioner, you may also engage in legal practice as a volunteer at a community legal centre.

Change of information

The Board is required to maintain a public register of local legal practitioners, locally registered foreign lawyers and law practices. Pursuant to s. 6.2.24 of the Act, practitioners are required to notify the Board of any change to the information held on the register within 14 days after the change occurs. Failure to do so constitutes a breach of the Act.
