When you have a chance, please obtain from Boris Buick a copy of the suppression order in the Dale proceeding. I gave some telephone advice this morning to Inspector Richard Read of the Media Unit this morning based which was based on the text of the order being read over the phone. The terms of the order read to me were to the effect that it is prohibited to make a report of the whole or any part of the proceeding and it is prohibited to report any information derived from the proceeding.

FYI: Boris had heard that The Australian's Cameron Stewart, Associate Editor is planning to run a story on the weekend to the effect that Gobbo will be a witness in an upcoming criminal proceeding against Dale and then informed Richard Read from the Media Unit to voice his concern about this having regard to security issues.

I advised Richard that from the breadth of the terms of the suppression order he had read to me, it is arguable that the proposed report by Stewart is a breach of the suppression order. As a consequence, Richard Read plans to call Stewart, tell him that Vic Pol considers such a report would breach the order and to not proceed with it and otherwise give notice to Vic Pol of any futire plan to publish about the case.

My thinking is we should have the suppression order on hand as we may need to take any concerns to the presiding judge at short notice - if anything to perhaps tighten suppression and other security-oriented measures available to the court.

Out of interest, Stewart is the journalist who received the tip-off (allegedly from a Vic Pol member currently awaiting trial over the matter) in relation to the Holsworthy Army Base terror plot which The Australian published a couple of hours before arrest warrants were executed.
