On the 30th of June, 2003 I attended Melbourne Pathology (PII [REDACTED]) and spoke to the receptionist (PII [REDACTED]). She confirmed that a male stating that his name was Carl WILLIAMS attended at the clinic with a male by the name of [REDACTED]. She stated according to the log, which I inspected, that both males had a blood test. She did not know for what they were tested. The log states that these samples were taken at 10.15 hrs by nurse (PII [REDACTED]).

She further stated that people do not make bookings, that the process is that they receive a referral from their doctor and just attend.

WILLIAMS referring doctor was Dr. (PII [REDACTED]) of (PII [REDACTED]) St. Sth Yarra Ph (PII [REDACTED]).

I attended their Melbourne Pathology Camberwell office and spoke to (PII [REDACTED]) who remembered both WILLIAMS and [REDACTED]. She stated that they "made a fuss" about how long the process took. She stated that they had to wait and did not seem pleased about it. She further identified a photograph of Carl WILLIAMS.

She stated that they arrived at about 9.45a.m. and would have left about ten minutes after the sample was taken. I.e/ 10.25a.m.

- Stated that he spoke to Nicola GOBBO on the phone twice that morning. (confirmed by GOBBO)
- Stated that he had heard about the death at approximately 1.30 p.m. to 2.00 p.m. but does not remember how.
