Corroboration of the Williams Statement

Some matters have been corroborated relative to this statement. In particular a phone call between Williams and Dale has been located on a Purana line.

Williams Plea and Sentence

The plea is set down for the 27th of April 2007. At this plea I will present a confidential affidavit relative to the Williams statement. A suppression order will be sought preventing publication of the statement or any other material relative to this investigation.

Briefing of Legal Team

No date has been set for this briefing. It is hoped that it will happen in the next 2 weeks.
