Weekly Update: 07 September 2009

Op. LORIS

Investigation relating to double murder of Terence and Christine HODSON.

Update (as per Interpose) -

Brief served on solicitors for both Collins and Dale within time frames. Further SD transcripts to be provided; audio served.

Form 10A received from defendant – DALE. 25 witnesses requested, including and Witness F.

Witnesses AHMED, HAYNES
 added to the 10A.

Form 10A received from defendant – COLLINS. 18 witnesses requested.

Committal date - 9 March 2010. Booked in for 3 weeks.

Subpoena received at office on 24 August 2009 from solicitors representing Collins, subpoena available for perusal. Required to assess subpoena prior to Friday mention and give advice to court in relation to what we would be prepared to provide, refuse, or sanitise. Will require adjournment to complete full assessment of subpoena and give advice to court.

Issue concerning Gerard MacGuire has arisen with witness F.

Special Mention heard on 28 August 2009; adjourned to further mention on 1 October 2009. Required to give advice to court on that date as to what will be provided and what will be objected to. Defence for Collins instructed to provide new more specific subpoena that will be argued on 1 October.

About 10 percent of current subpoena content agreed to and will be provided prior to 1 October.

Barrister Ron Gipp briefed and appeared on 28 August.

Request for unsworn member to be attached to Petra in relation to subpoena management; liaising with Crime operations Support re same.

Still no subpoena from Dale. Advice is that Dale has been refused funding by TPA.

Dale Bail Application

Application for bail refused by Justice Byrne in Supreme on 10 August 2009. Found that he was an acceptable risk in relation to witnesses.

Dale is still in Acacia. Corrections are currently exploring options to have him moved. Legal representatives have written to Minister in relation to the Human Rights Charter and the comments of Justice Byrne.

Have received application to Court of Appeal from Hargreaves on behalf of Dale. Seeking leave to appeal on grounds of error at law by Justice Byrne in that he reversed the onus to the defence in relation to 'unacceptable risk.' Matter being considered currently by OPP as to whether court has jurisdiction to hear appeal.

Op. BERIME

Investigation relating to double murder of Ramon and Dorothy ABBEY. Offender – Rodney COLLINS, charged with Murder (2 counts)

COLLINS trial booked in for four weeks commencing 5 October 2009.

Preliminary work commenced. Geoff Horgan will prosecute.

Op. HETMAN

Armed Robbery / Serious injury shooting on 14th May 1987 at Samco Meats 5 Lyon St, Coburg North. Suspects: Ray ABBEY (deceased) and Rodney COLLINS.

Committal – 3 & 4 August 2009

Collins committed to stand trial to Supreme Court on all charges; attempted murder and armed robbery. Listings hearing in November.

Op. MINCER

Investigation into the murder of Brian KANE in November 1982 at the Quarry Hotel, Lygon Street, Brunswick. Two unknown males, wearing balaclavas, observed committing the murder. Nominated Suspects – Russell COX and Rodney COLLINS.

- Witness has provided information that COLLINS admitted involvement, with COX, in the murder. Statement obtained from

 - COLLINS admits to murder

- Investigation plan submitted and approved

- Investigation has been elevated to primary investigation for Petra together with Queazy; with additional resources added to investigation.
- Surveillance on Greenslopes has confirmed Cox in residence at that address with wife Helen Deane.
- Telephone Intercept on Mobile phone commenced 21 August. Cox uses a number of different aliases and appears to be involved in building industry in some capacity. Currently about 12 calls a day.
- Affidavits at ESD TMU in relation to LD on and LD at Cox home address.
- Application to be made in relation to reward increase.
- Investigators travelled to Qld on Wednesday 26 August to formulate JIA with QPol Homicide Squad. Also meet with QPOL and and formulated investigation plan.
- Significant surveillance on Cox and Deane. Intend to conduct LSD and tracker install on house and car last next week. Two Petra members and member of TSU will travel to Qld to provide advice and assistance.

Case Review completed of investigation into the murder of Paul Kevin
Cremmen at A Division Pentridge on 6 May 1990. Review conducted by Petra
due to Cop involvement of Collins.
Evidence indicates that Collins involved 'after the fact,' in that he has
apparently assisted in moving the body out of sight under bunk to prevent
immediate discovery and disposal of bloodied clothing. Not involved in murder
as principal; would be difficult to prove knowledge prior to killing.


Committal - 21 October 2009 (4 days)

Hafner discharged due to three witnesses not swearing up to statements, nil costs; obvious interference from Hafner and wife Biliana. Investigations have revealed sufficient evidence via Arunta calls and formal interview of wife to charge them with Pervert Course of Justice. Once this process completed, witnesses will be re interviewed and approaches made to OPP to have Hafner directly presented.

On 26 May 2009, Witness F received 4 SMS text messages, between 1.58 pm and 6.03 pm, which contained threats to the life of the witness.

Phone analysis continuing; have downloaded about 200 SMS messages from seized phones.

VO will be interviewed Wednesday 09 September 2009. Not expected that there will be sufficient to charges other than drug and theft related matters.

It would appear that phone dealer QUACH has been selling up to 30-40 prepaid SIM cards a day and has used the same address of the 'threat phone,' on a number of occasions. We are proceeding on the basis that VO obtained card but it is possible that he obtained SIM's separately and 'threat' SIM obtained by unknown. Obviously no CCTV or records at QUACH's.
