The Source Development Unit has previously provided Briars with access to transcripts relative to 3838's contacts with one of our targets, David Waters. I understand that because of the vast quantity of material supplied by this source that in order to quickly provide the transcripts that I have the unit simply did a search on the name of Waters and provided me with all contact reports containing that name. On examining that material and after speaking to 3838 it appears that we do not have all relevant source contact reports.
