Simon

Plans are firming up and we four need to get our leave / absences in view for the rest of 2010. I will ask Stephen to coordinate that if you like. I am going on leave on Monday 21 June until Wednesday 4 August. In my view you need to consider an acting DC as the tempo / intensity of my work is now such that I don't think it can be adequately covered by Ken / Kieran. There is also the added complication of Driver / Petra and the emergence of the Fraser / Jama reports.

I know you have few options in this area and they in turn are qualified by the boundary change implementation. That said I think some of the work we are getting across here is of equal importance - and higher risk. If you agree with this reasoning then it seems you maybe restricted to Tim Cartwright, Steve Fontana and Dannye Moloney. Tim is, in my view, the most capable in a general sense but will be in the thick of boundary changes (which he could manage from here in any event) but he has gaps in the very high risk areas in Crime. Steve is less taxed in his current portfolio but the bushfire commission activity / reporting may change that, he also presents some gaps in the high risk areas. Dannye has the advantage of being best to handle Crime issues and Driver in view of his particular background. But you might have other views or candidates. Can we discuss together before taking this wider?
