It also includes numerous surveillance logs from the Victoria Police surveillance unit which commenced on 27 June 2003 and continued on and off through to 25 October 2003 none of which include and as a target or relate to the relevant period in respect of these charges, namely the week leading up to and including the date of Saturday 2003. The additional material includes listening devices which really relate to and home and cars as well as a mean home commencing in September 2003. All of this relates to and subsequently in part is contained in the brief of evidence relating to the murder of which does not concern The additional material contains Police/Investigator diary notes and day

book entries.

We are able to provide Counsel with a copy of these notes but Counsel is advised that there is little if anything of relevance contained therein. At least anything that may be of interest has been blacked out.

A Summons was issued on behalf of **and and returnable on and and 2005**. Counsel will find enclosed a **copy of that Summons and the written response from the Victorian Government Solicitor** on behalf of the Chief Comissioner of Police. We anticipate receipt receiving additional material pursuant to that Summons prior to the commencement of the Committal. A further Summons is to be filed and served in relation to the records or use of **and and e**-tag given that this may assist in relation to determining what his movements were or weren't in the week leading up to and including 2003.

This document has been redacted for Public Interest Immunity claims made by Victoria Police. These claims are not yet resolved. The last issue to be covered by way of summons relates to numerous mobile phones used by **and a service** during the relevant period. We anticipate that a Summons to each mobile phone service provider asking for call charge records will also be returnable prior to the committal commencing.

Should Counsel consider it appropriate to issue any further Summonses for any other material please advise and we will file and serve them accordingly.

PERSONAL BACKGROUND

For Counsel's information only, it is apparent that **a second** had become a person of interest to the Purana Taskforce as a result of his associations with a number of alleged "underworld" figures. It is **a second** belief that the reason why he is charged is largely on the basis of the Purana Taskforce trying to make his life and that of

as difficult as possible with a view to him doing a deal and giving evidence against Carl Williams. Under no circumstances will entertain any deal whatsoever. Since his arrest in relation to these charges, he has been the subject of: -
