Boss,

I spoke to Ron GIPP this morning. HARGREAVES have sent the VGSO a letter yesterday asking for further documents in relation to some specific areas, outlined in the letter attached.

The first area is in relation to the ATO matter. Are there any further documents in the possession of VicPOI dealing with the negotiations? We will need to know if Mr OVERLAND has any notes of any negotiations. Ron has asked if this inquiry can be done as a matter of urgency.

Regarding the F transcripts, Ron has responded to this issue and explained that the redactions relate to PII claims and this requires no input from us.

Regarding the F letters to the VGSO, Ron will inquire with the VGSO about what letters they have and will assess them for claims, but he asked if either you or Shane have notes or letters from F regarding the negotiations with F. If so, Ron wants a copy so he can assess them for PII.

Ron is concerned that if there are documents that exist that we have not informed him about then VicPol will look like it has tried to hide something from the defence. Can you please ensure that anything that does exist Ron is made aware of in order to assess the material.
