Tony: "Nah not much. I ran a, I ran something across me barristers and Hargraves. I said, look this'll probably assist the Drug Squad it'll probably assist a bit of Homicide and this and that. Ya know, take a lot of pressure off, ah, the hierarchies and, ya know, this and that and. He goes, what's that? I said, look I've spoken to Carl Williams, look I've spoken to, um, well most of the biggest cases youse have got in the Drug Squad game okay.

Which is

Bartlett: "Yeah."

Tony: "Um, and I think there's another two cases. I've, I've, we've spoken to everyone of them and I said if we, if we nod our heads to some of these charges, are youse prepared to nod ya head and we'll just go in instead of. Because what I worked out it's going to take two or. By the time you prosecute the whole lot of us, especially my case, I mean you're looking about eight month's committal to, ah, trial god knows how long. It's going to be like two or three years in court."

Bartlett: "Yeah."

Tony:"Like just in court, court dates, ya know what I mean?"Robertson:"Yeah."

Tony: "Forget about who wins or loses at the end of the day. I mean I'm sure you're pretty confident and I'm sure we're pretty confident our way, and we don't want to unearth any more on any other people and things like that. I mean, as you can imagine ESD has driven me mad to come and make a couple of statements again. I said, I wouldn't do that, it's not in my nature and that's just the way I am, ya know what I mean? I've never made it against anyone and I never will. And, ah, the thing is at the end of the day I thought if we sit down, take a bit of chip off our, our shoulders, bit of chip off your shoulders and we just come to a reasonable, bit of reasonable conclusion arid. I don't know, it's just, it's a hy, ya know, it's hy, ya know, hypothetical or whatever. But what I'm just, we're just curious to what you think of it. We, Con and that's probably going to ask Coughlin when he gets back. Con gets back on the 20^{th."}

Bartlett: "Halliotis?"

Tony: "Yeah."

Bartlett: "Yeah."

Tony: "Okay. He's going to ask Paul Coughlin what's he think of it. Because I think it'll give peace to the streets, number one. If we all go in there, well at least this way everyone can do their investigations properly on the Homicide side of things and that way, then no one can say oh they were intimidated or anything like that or. So, if we're in there, we're in there, ya know what I mean? Like we go and do a little bit of time and leave the streets to youse."

Bartlett: "What, what matters are you talking about?"

Tony: "I just told you, all them cases. So this way here it saves like maybe two or three years of bloody court costs. When

you look at it between everybody's cases, ya know."

Bartlett: "Yeah."

Robertson: "What, what would be in it for the police if that was to occur Tony?"

Tony: "Well youse get peace. Well number one, the community. The thing is look at the end of the day honestly we're going to go there and while we think we're being loaded or whatever. I mean I'm not going to get into ..."

Robertson:"Yeah."Tony:"... of the cases, right."Robertson:"Yeah that's fair."Tony:"And unearth, and we, we got, I especially me, I got a lot

more ... (inaudible).., information on which police worked with who and whoever and I'm just going to throw names left, right and centre in these bloody court cases and, and make it a nice messy case. And my case won't get on, you know yourself, if I want to drag this case for 4 to 10 years I can, because of all the subpoenas and things like that. It won't be too hard at all. I mean look at Boris Beljajev case there was only one copper in question and how long did he go for? That went for 10 and a half years."

Robertson: "Mm."

Tony: "Ya know what I mean? But the thing is at the end of the day like I don't want to go through that road if I don't have to, ya know what I mean? If I take a bit of chip off my shoulder and think I've got a good case to be tired, the tape's probably, there's a lot to answer to in a lot of ways. But there's, there's also, we believe we got the answer to some of them."

Robertson:"How are you going to get all these people on board?"Tony:"I've spoken to all of them. But they all said, they all saidthe same."

Robertson: "How are you going to keep them all?"

Tony: "They all the said the same thing, they said they don't want to be back doored. No, we don't want to go in there thinking oh he does 2 or 3 years, he does whatever and then fuckin' next thing you know you get an 8 or a 10 and then I fuckin' my life's in jeopardy, they'll think that I've set them up."

Robertson: "Mm."

Tony: "Okay? So that's why I said to Con, I said that's something you and Paul have got to sort out. If it comes to that stage, if Paul says yep but, ya know, if it comes to that stage and, ah, I said the way they did it with Johnny Higgs' case, which Paul signed a letter behind doors. And he got his arse kicked for it of course. Ya know, I said but at the end of the day you get one judge, which exactly what I said to fuckin' silly, that fuckin' silly Marty Allison, he's a fuckin' goose. That's why Strawhorn's in there, okay. Wayne - ' Strawhorn's in there. If it wasn't for fuckin' Marty Allison. I said this to, I, I had them all on toast in, when I was in inside. I said this to Strawhorn and, ah, and Marty Allison. Marty Allison goes, no get fucked, none of this, nah, jumped up and down like a fuckin' goose, right. But the thing is at the end of the day these blokes trust me, okay. I can give you, right now. I've spoken to all of them."

Robertson: "Mm."

Tony: "And they've all said, Tony the reins are with you, okay. You can get us a good deal and, ah, we'll get one solicitor, one barrister, which they all trust Con, they all trust. I don't . know about which Hargraves or not, but I thing is I'm trying to get them all to Tony Hargraves, okay. You go in there, and I think the, I think the Police Association have got to say. Like Nixon can turn around or whatever, I'm not going to tell them word for word. But at the end of the day we couldn't prosecute these guys properly like we had to, and you can put the shit on Rosenes and Paton because at the end of the day they were in charge of a lot of these fuckin' cases, okay. And because of the corruption side of things and whatever and, and, ah, therefore we've got them on a, what do they call it, and this and that. There's ways around it and, there's ways of getting around it. And you've got, like I said the best part about it is you got 2 or 3 years of, of court cases you don't have to worry about and, not only that, the best part about it again is it's internal now. You haven't got the crims bagging the fuckin' coppers any more. You haven't got people throwing mud left, right and centre on anyone any more. And it can be done under wraps."

Robertson:	"Yeah."

Tony: "Okay?"

Robertson: "Oh well I can see where you're coming from."

Tony: "Yeah."

Robertson: "I don't know what merit's it's got in it but. How's this, I'm from the Purana Taskforce."

Tony: "Yep"

Robertson: "How's this going to stop what's, ah, the killings out on the streets?"

Tony: "Well nothing can assure you that's going to ever happen. I'm just saying, but I'm saying like let's say."

Robertson: "I mean that seems to be the main concern as far as. If I ..."

Tony: "Oh."

But like I said with Homicide they should be, I know youse are under a tone of fuckin' pressure from the hierarchies, okay. But the thing is at the end of the day that's, if they put me away, if they put Carl Williams away and, which Carl's more than happy to do a deal, I just left him now, not even

But he also doesn't want to see suffer to the maximum and obviously I don't want to. We've got a top alibi for right, but the thing is at the end of the day, ya know, you've got to give and take again, ya know what I mean? You can't, you can't expect, you can't, now half these blokes I'm talking to they reckon they can beat their cases, okay. That's what their frame of mind is. So you try to tell someone you're going to be guilty of something, and they got half of their mind, alright. It's going to take a bit of persuading. But I'm, I'm confident I can persuade it, okay, because I have spoken to these people."

Bartlett: "So what are you proposing?"

Tony: "Well, well number one if you, if you reckon it's a good idea, I'll let Con talk to Paul, okay. Paul Coughlin then, let Con talk to Paul." Robertson: "Yeah."

Tony: "And see what Paul thinks of it. Now I'm sure if he gets a little bit of pressure from you blokes saying, Paul look it's not a bad idea, it's not as silly as it looks, okay. It ain't as silly as it looks, okay. Let's go to pen and paper now, let's see what people are prepared to plea guilty to and let's see what we're prepared to bend to and, ya know. It might take 3 to 6 months but I'll tell you right now I'll guarantee you by the end of the year if you want to do this, this will be done. Everyone will be in. And then you haven't go no more fuckin', you haven't got no more court cases going down, they're just

putting shit on the coppers and making it look badder than it is. Which Nixon will appreciate it. And as far as the corruption goes between the police and the fuckin' ESD, well it's internal then. It's fuckin' internal. The only one I can't get,

is probably You

know what he's like, I wouldn't trust him. He's, what I mean I wouldn't trust him, one minute he'll say yes and then next minute he'll do me a fuckin' somersault. But the blokes I've spoken to they said, Tone if you reckon you can put this together we're more than happy. If you reckon it's a fair deal."

Bartlett: "But as you'd appreciate that's not up, up to me to make any way these things."

Tony: "Or me or you. I'm just saying at the end of the day. But if little bit helps from every section. I'm sure Paul Coughlin doesn't want his system while he's under fuckin' wraps with his system, to be in turmoil. Okay. And his system at the moment. We go into the magistrate and you can see they're sickened by what's going on, okay. The judges are sickened by it, ya know. You can see it by miles away."

Robertson: "But the argument can go the other way. The magistrates are now, I mean the killings have turned the heat on you blokes. You've actually, and I mean whether you're involved or not, we'll bypass that issue. But that's turned the heat up. And next time you walk into the magistrates court and next time you look at changing your bail conditions, you're not going to get the same reception."

Tony: "Well."

Robertson:"Because the magistrates are reading the papers andthey're saying, no these blokes are actually killing people now, they're not justdealing drugs. And you mightn't find it as easy as you used to."Tony: "Well you might be right and that's what I'm saying."Robertson:"Yeah."

Tony: "They're going to turn the system into turmoil aren't they? Because of some mad magistrate."

Robertson: "Well it's going to be problem."

Tony: "Let's assume some magistrate starts making noise and, ah, and it's going the other way, which I'm sure they probably will. And then you got to go to County Court and they're going to do the same. I mean what's the good of that if you're going to turn your whole system just to crucify a couple of blokes and everyone's going to use their judgments against them? Do you follow what I'm trying to say?"

Robertson: "Yeah, oh yeah no I can. I can see that everything, everything's turning around and it's not."

Tony: "It is, it is and it's ridiculous, it's fuckin' stupid and not, above all it's. I, and what's what I'm saying. At the end of the day, if you can take the strength away from the streets."

Robertson: "Mm."

Tony: "Okay? Youse are going to have a good grip of the fuckin" streets. I'll tell you now, Homicide will have a massive grip of the streets." Robertson: "Mm."

Tony: "That's all I can tell ya. I can't tell ya any more than that." Robertson: "Well what about if I put this proposal to you, alright. And I'm interested in solving the murders, right, primarily. If you were, if you were to assist if you could assist in that regard, well the, ya know, obviously it would put you in a better light further on down the track with your court case."

Tony: "Ya know what I mean? But the thing is."

Robertson: "It's not good. It's not a good situation for the police and ..."

Tony: "Oh look I, I."

Robertson: "... it's not a good situation for you."

Tony: "I'll be honest with you, ya know when Graham

Tony: "Okay. That's where, that's where the minus is. But if they sit there for a few, few, few months, okay, and with good lawyers and good barristers or whatever it is, the way they're going to address the media about all this."

Robertson: "Mm."

Tony: "I think you'll find, especially if you can get a couple of pinches over it while these blokes are doing away. If you get a couple pinches over it or whatever I don't know, right, for your investigation. Which I'm quietly confident you will. But the thing is at the end of the day that makes everybody look good and it's a plus, plus, plus."

Robertson: "Mm."

Bartlett: "Yep."

Tony: "Okay."

Robertson: "Yep."
