

WITNESS F: And I mean the answer that I believe Harrington was given was, "Look, I was just asked to go and see him, you know, how people get arrested and they ring five lawyers and - - -"

DETECTIVE INSPECTOR O'CONNOR: Yep.

WITNESS F: "And nothing ever came of it and he didn't retain me and that was that." Well, that's just complete rubbish. That's not the reason why he went - that's not the reason why he went to see Johnson. He went to see Matty Johnson to do with the messages on behalf of crooks.

DETECTIVE INSPECTOR O'CONNOR: On behalf of?

WITNESS F: A couple of crooks.

DETECTIVE INSPECTOR O'CONNOR: And who are those crooks?

WITNESS F: Oh, what's his name, Bubbles, which is Mario sorry, Raymond Sassine, S - double A-S-I-N-E.

DETECTIVE INSPECTOR O'CONNOR: S - double - - -

WITNESS F: S-A-S-S-I-N-E.

DETECTIVE INSPECTOR O'CONNOR: Yep.

WITNESS F: Nickname Bubbles. He's on bail for a large commercial

DETECTIVE INSPECTOR O'CONNOR: Yep.

WITNESS F: And for - he in turn connected to Rob Karam.

DETECTIVE INSPECTOR O'CONNOR: Rob?

WITNESS F: Karam, K-A-R-A-M.

DETECTIVE INSPECTOR O'CONNOR: K-A-R-A-M.

WITNESS F: From - - -

DETECTIVE INSPECTOR O'CONNOR: AM - M or N?

WITNESS F: M for Mary.

DETECTIVE INSPECTOR O'CONNOR: Mary, yep.

WITNESS F: - - - I have - I have a - a mild interest in why Carl was murdered 'cause of obviously the position that he was in, I'm in the position I'm in.

DETECTIVE INSPECTOR O'CONNOR: Yep, all right.

- WITNESS F: As I said, like, look, I just wanna express this, John. This is not some - from my point of view, this is not some kinda game or, you know - I mean, look at it from my point of view. someone from your office 'cause of the ongoing issues that might rise in relation to me hearing about the fact that, for example, I'm going to be the subject of a subpoena in an upcoming court case wherein I'm the source of the information and in the past, and I was talking to one of Sandy s boys, I could at least say, "Look, there's middle - this is what they're subpoenaing and I feature in it, can you please make sure that my name isn't anywhere." And because of the fact that during the start of the Dale committal I was called an informer in an open court room, over the space of seven or eight days, I have got genuine concerns that - that people are gunna issue subpoenas and they're gunna ask things and I just want your office to know about it in advance, when I know about it, so that I can release some of my stress by saying, "Look, it, you know, here it is, can you please do something about it."
