- (b) I refer to paragraphs 35 to 39 above which deal with the Briars taskforce Management Committee documents (including minutes and records of meetings) and any handwritten notes contained thereon. Any material which is not the subject of a public interest immunity claim will be supplied in a similar format to that previously referred to in relation to the Mullett subpoena.
- (c) None of Chief Commissioner Nixon, Chief Commissioner Overland nor Asst. Commissioner Cornelius use a handwritten diary. I am informed and believe that with the exception of the handwritten notes in respect of which edited release has occurred there are no electronic scheduler entries which would satisfy this request.
- (d) The document entitled "Operation Briars" Linnell & Ashby Chronology and the running sheet compiled by Chief Commissioner Overland as previously referred to have already been provided together with the affidavits of Messrs. Overland, Cornelius and Linnell.
