I have been following the breaking story of Lawyer X in the newspapers and have become concerned over the value of her advice in representing myself in 2 major matters against Victoria Police in 2007 and 2008.

Firstly, after numerous meetings at her chambers throughout 2007, she convinced me to plead guilty to police charges that I steadfastly believed I could defend and win, or at the very least tie up police resources, which I was renowned for doing in the past issues.

I am now worried that Senior Police were concerned about the consequences if I win and urged her to mislead me into pleading guilty, which would load up my convictions i.e. Perjury etc. so that I would no longer be a threat to them, as I had been over the last 10 years when the war between police and myself began.

Secondly Nicola Gobbo (Lawyer X) advised and represented me when my solicitor Rahmin de Kresta engaged her to handle my 47 proposed charges against Victoria police over the last 10 years. Consistent with the war on Victoria Police it was my turn to use their tactics against them.

After many daily visits to investigating police at Headquarters, reviewing the strength of my evidence in each matter, Police were clearly concerned so much so that Nicola Gobbo told me that police were threatening her career. I told her that a lot of time and money went into preparing the cases against so many police!

At my next visit to police headquarters I was outraged to hear that they knew Nicola advised she couldn't continue and as a result, they were no longer prepared to continue investigating my charges. As simple as that - it was all over- a dead duck in the water.

I returned to Nicola and demanded why she advised police, before me and what to do next.

Then a strange story emerged involving her current actions, relationship with Gatto, who she said admired me taking on the police and Mokbel's phone calls

from overseas, and how they knew police were listening in, even to the extent of saying "hello" to them as part of the conversation etc.

In hindsight this may have been Mokbel's undoing! Finally she confided that my lawyer Rahmin was capable of continuing my charges etc.

I recall saying that was nonsense - "the only person is me & you know that". She agreed, however.

I brought up the fire bomb in her BMW and said "I bet it was the police?"


And she said, "It looks that way!"

She then advised me she was going away soon and said she was sorry she couldn't help me further. I then contacted Rahmin over the above outcomes.



- Our client continues to suffer from health problems; and
- Police maintained their possession of documents seized in relation to Operation Loops until March 2008 without any charges being made.
