On Wednesday 21 January 2009 I listened to a number of recorded telephone conversation played to me by Detective Senior Constable ROWE. These calls were played to me in chronological order.

The first CD was labelled Operation ORBITAL, Promis No: 3412233, Telephone Intercept Product, re: Warrant

The second CD was labelled Operation QUILLS, Stock No: 4309-4, Warrant

The third CD was labelled Operation QUILLS, Stock No: 4303-4, Warrant The recordings I listened to were as follows:

# Warrant Track 1 – call 3, recorded at 5.32 p.m. on 1-July-2005.

This call contains two male voices. I have identified one of the voices as mine, and the other as Eddie's. I have previous made numerous statements about Eddie and his involvement in manufacturing ecstasy. During this call we discuss meeting up. We arrange to meet along the Brunswick train line off Victoria Street. When I say 'where I normally meet him' I am referring to Tony MOKBEL.


