- we met @ 7:45 to 8:00

para 33 - <sup>Mr Thomas</sup> said he'd been to Xkeys reserve to look for Jason but he wasn't there yet.

para 34 - <sup>Mr Thomas</sup> was wearing a hat, sunglasses & a puffy orange jacket (disguise?)

para 35 - <sup>Mr Thomas</sup> did numerous trips around the pub looking for Jason

- <sup>Mr Thomas</sup> reported Jason not there

- we all decided to try again next week

para 39 - later that afternoon me, cw & <sup>Mr Andrews</sup> met @ Carl's

- aim was to find Jason & kill him

(looked for him but couldn't find him.)

para 44 - we decided in the end to do nothing & wait for next weekend

para 45 - during the week I had a fair bit of contact with cw & <sup>Mr Andrews</sup>

(no mention of <sup>Mr Thomas</sup>).

para 46 - Tues night, me, cw & <sup>Mr Andrews</sup> discussed killing Jason  
(no mention of <sup>Mr Thomas</sup>).

para 47 - on the Tues night we went to location, planning mtg  
(no <sup>Mr Thome</sup>)

para 48 - on the day before the shooting (later that night)  
CW, <sup>Mr Andrew</sup> <sup>Mr Thomas</sup> & me met @ milk bar @ end of  
[redacted] street

- discussion re: murder but no mention of <sup>Mr Thomas</sup> [redacted]  
saying anything

- after murder no mention of <sup>Mr Thomas</sup> [redacted] anywhere

1. My full name is <sup>Mr McGrath</sup> I am [REDACTED] years old. I am currently undergoing sentence at <sup>PII</sup> [REDACTED] Prison for <sup>PII</sup> [REDACTED] offences. I am also on remand for the murder of Michael MARSHALL.
2. I am making this statement to the police in order to give my full involvement in the murder of Jason MORAN and Pasquale BARBARO. I make it in the belief that none of the information contained herein can be used against me in any future proceedings.
3. My role in the murder was to drive <sup>Mr Andrews</sup> to the scene. We committed these murders on behalf of Carl WILLIAMS. When I say that I mean Jason MORAN was killed because Carl wanted him dead. Unfortunately Pasquale BARBARO was a victim of <sup>Mr Andrews</sup> over zealousness. He was simply in the wrong place at the wrong time.
4. Carl's motive for wanting Jason MORAN dead goes back a long way. In fact there is a number of motives. The prime motive was that Jason was involved in shooting Carl in the stomach. This occurred sometime in 1998 or 1999. I know this to be the truth because Carl told me. I think he told me sometime in the year 2000. I recall we were at some hotel having a drink. I had heard previously that this had happened but this was the first time that Carl had told me directly. He was more prone to opening up when he had a few drinks. He told me that Jason and his brother Mark shot him. He did not tell me which one pulled the trigger. He did not tell me what it was over and I did not ask him.
5. In June 2000 Mark MORAN was murdered outside his house in Comberemere St Essendon. I have first hand knowledge that Carl committed this murder.
6. After this incident it was well known in Melbourne criminal circles that Carl WILLIAMS was responsible for Mark's death. It was also assumed that Jason would

want to seek revenge. In fact it was well known that Jason had put a price on Carl's head. That is, he was offering money to have him killed. Carl was well aware of this also.

7. Since being shot in the stomach Carl became obsessive about the MORAN family. Whenever he was drunk and the conversation came up he would start saying things like "I want everyone of them dead and everyone of their crew dead".
8. To this end he had me perform certain tasks, these included performing surveillance on Judy MORAN, Lewis MORAN, Jason MORAN, Mick GATTO and Graham KINNIBURGH.
9. Through Carl's information and my surveillance I found out that Judy MORAN was living in a house at (address deleted). (location description deleted). I also knew that she drove a white Ford sedan.
10. With Lewis MORAN, I watched him drinking at the Laurel Hotel and his house in [REDACTED] Essendon. Carl also told me that he would occasionally stay at a house in [REDACTED] Essendon. He would stay at this house with a woman with the surname of [REDACTED]. The house was the first on right as you turn from [REDACTED]. I had a look at this house on several occasions. I went through the bin a couple of times. In fact that is how I came up with the name [REDACTED]. Carl wanted me to report to him when would be best time to get him.
11. I also looked at Jason MORAN's house in [REDACTED] Moonee Ponds a couple of times.
12. I only went to Mick GATTO's place once in roughly August last year. His house is in East Doncaster. I don't remember the street name but his house backs on to a park. The house is on the north side of the road. It is a cream coloured sort of building. His

house is a fortress. It has a fifteen foot fence at the back with cameras everywhere.

13. I know that Graham KINNIBURGH lived at (address deleted). Again I think I only ever went to the place once. I think that was sometime in May 2003. I did not do a lot of surveillance on these people because I did not want them dead.

14. All my actions with these people were on Carl's behalf. I would tell Carl that I was doing more than I actually was, because when I reported to him with information he would give me some money. Usually around \$100. I would do this surveillance on an ad hoc basis for Carl until being gaoled on unrelated charges in [REDACTED] I was again released from gaol in April 2003 when I again started the surveillance on an ad hoc basis.

15. I remember discussing Carl's obsession with MORAN family with [REDACTED]  
[REDACTED] We were both worried about Carl killing people like Judy MORAN. We both were of the belief that this could send things out of control. [REDACTED]  
[REDACTED] It was in mid 2000. A shot gun was fired into Carl's front door of his house in [REDACTED] Hillside. A shot was also fired in to his Mercedes. I do not know who pulled the trigger but after it occurred [REDACTED] I spoke to Carl and told him if he went after Judy MORAN then people could just as easily get to his family. He seemed to take some notice of this. He certainly seemed concerned. He did not speak of killing Judy MORAN again after this.

16. About 4-6 weeks prior to Jason's murder Carl took [Mr Andrews] and I to the Cross Keys Reserve. I remember that it was late one night. He was driving a silver Ford sedan. When we arrived we parked in the car park of the hotel. We then got out of the car and had a short walk around the park. Carl told us that Jason brought his kids to Auskick every Saturday and that he thought that it would be a perfect place to kill him as Jason would think that he was safe there.
