- I have previously provided a statement in response to a notice to produce given under the Inquiries Act 2014. That statement referred to the fact that I would identify and list some specific examples of some of the primary topics expressed in the list of questions provided to me (see, eg., my answer to questions 12 (c) and 12 (d)). For my own preparation, I made the below notes setting out various examples which covered particular topics in the Informer Contact Reports that I compiled. For the sake of completeness and in accordance with the notice to produce, I produce these lists to the Commission. I have identified the topics as follows:- Risk Management, Welfare and Health, LPP and Confidential, List of 20 and Petra Handover Issues. I have not included details from the various conversations I was party to with 3838.
- Risk Management issues have been identified in the following details from the contact reports I compiled. They indicate to me the potential risks to managing this source. The potential for risk in managing every source relates firstly, to their and my compromise and personal safety, committing or becoming involved in crime, corrupting police, risk to the information and any public harm.
