Charlie and I where having a quick look around while I was speaking on the phone to Rob. Rob asked me if I would be right for 10 o'clock tonight. I told him that I was taking my missus out and that I didn't think I would be able to make it. I then asked him if I could do it in the morning, Rob told me that it would have to be early as he was staying at Crown. Rob then asked me out for dinner but I said no. I told Rob that Charlie would be with me and he said that was fine but he would only deal with me. Rob then ended the conversation by saying that he would be in touch.

We then sat down in the lounge room and Georgie came in and racked up 3 lines of coke. I told her that Charlie had to drive and that he wouldn't have any. Georgie then combined the three lines into two and then her and I snorted the coke. Georgie then spoke about how good the coke was.
