1 ---Yes. Again, I might add because of the pagination difficulty I'm 2 3 hoping that we won't need to do anything more than - the 4 witness has agreed that he said it. That was p.364 of 5 the Moran, Barbaro brief? --- That's right. 6 And I'm now going to read something two pages further on - - -7 HIS HONOUR: Well he can have it in - - -MR LOVITT: Well he'll have to get the alternate pagination 8 9 then which would normally take about five minutes 10 to - - -HIS HONOUR: Which folder do you have, Mr McGrath 11 12 MR LOVITT: I think obviously he's got the Marshall one? 13 ---Which page? 14 HIS HONOUR: Page 364. 15 MR LOVITT: He's got the Marshall one, Your Honour, we 16 established that before lunch? --- Page 519. 17 HIS HONOUR: Have you got Marshall or the other? 18 ---(indistinct). 19 MR LOVITT: Turn to p.519 thanks. 20 HIS HONOUR: Have you got that? --- Yes, yes I have. 21 MR LOVITT: About ten lines down Bateson says: "Well just 22 before we go up -" this is when you were going up to the 23 police station to have the recorded - tape-recorded 24 interview I want to get this straight in my mind -"? 25 ---Yes. 26 "- you are saying that you were trying to help us when all this happened?" And you said: "With what I'm charged with 27 28 now?" He said: "Yes." You said: "Yes, after he did what 29 he did, and yes I can tell you other things too that I where I can prove I tried to help you." Is that what you 30

told them? --- Yes.

1	Was this based on, what, some idle chitchat that you overheard
2	or took place in your presence?It took place in my
3	presence.
4	MrThomas wasn't involved in any discussions about killing Jason
5	Moran, I suggest, Mr McGrath He's someone that you've
6	added to the equation, perhaps at the request of the
7	police?No, MrThomas was definitely involved in the
8	murder of Jason Moran.
9	You know that after the killing you don't mention his name
10	once? After the night before you don't mention his name
11	once. It's as if he disappears off the face of the
2	earth?Which day are you referring to?
13	I think the night before is fairly plain, isn't it, the night
14	before the killing? Does that confuse you at all?I
15	understand now, yes.
16	You see after you've finished describing what happened the
17	night before, a meeting in a milk bar where there's talk
18	about the killing and MrThomas there, that's all you say.
19	You don't say said anything? You don't mention him
20	at all after that, do you?No, he wasn't - he wasn't
21	down the day of the killing if that's what you mean.
22	No, but you don't mention him. You don't even mention talking
23	to him or getting his reaction or speaking to him on the
24	phone or anything, do you?No.
25	That's because, I take it, you didn't speak to him on the phone
26	after the killing, that day or subsequently?No.
27	Do you reckon you've actually seen him since the killing, until
28	you got locked up?It's possible but I don't recall any
29	specific dates.
30	The last thing I want to ask you about is what happened when
31	you were sentenced. The Crown asked for you to be dealt

2	Justice Teague, heard the plea and then later that same
3	day, 19 January, he imposed the sentence, right, and
4	that's where you got - what was it an 18 with a 10?
5	Yes.
6	He told you that were it not for your co-operation you would've
7	got a minimum of twice that much with another 10 years on
8	the bottom?Yes.
9	Of course you know jolly well, don't you, that given your
10	admissions concerning the Moran/Barbaro killing, and
11	indeed your admissions, such as they area, in relation to
12	the Mark Moran killing, that if you were dealt with for
13	four execution type murders you can expect to go to gaol
14	for a lot longer than a minimum of 20 years, probably 30
15	years, if not longer, maybe never get out, don't you?
16	Yes.
17	So the stakes were pretty high for you, weren't they?Yes.
18	When the plea took place Mr Langslow appeared on your behalf,
19	didn't he?Yes, he did.
20	He said some things to the judge that I just want to raise with
21	you to see if they accord with what your instructions
22	were. He said at p.24 of the transcript, "It was clearly
23	suggested to that no more than an underworld
24	debt collection was planned and, secondly, that Mr McGrath
25	agreed at that late stage when there hadn't been the
26	previous arrangement, at that late stage to drive
27	to the vicinity of Marshall's residence in the Vectra",
28	right?Yes.
29	Did you tell Mr Langslow those things?I believe so, yes.
30	Was the Vectra - that's your car - did that have false plates
31	on it that day?No.
