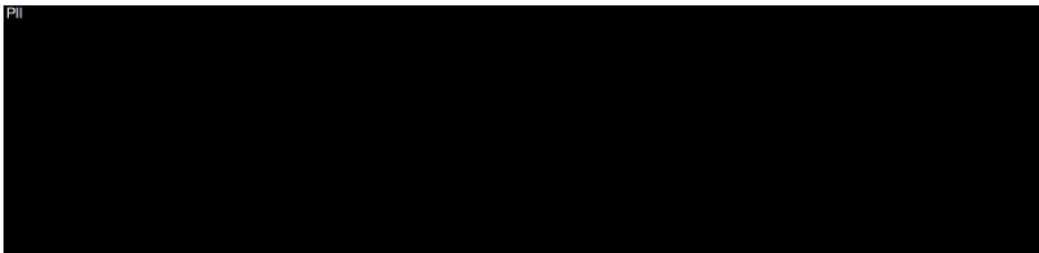


Petra TaskforceWeekly Update: 9 July 2007Taskforce Activities

- Members are continuing to review Operation Galop and Nutation material. At this early stage the burglary together with the leaking of information reports seem to be the best motive for the Hudson murders.
- Members have spoken to a number of friends of Paul Dale who attended the BBQ at his house on the day of the burglary. All confirm he was at the house for the BBQ. Some left prior to the time of the burglary but are convinced Dale remained at the house.
- LEAP audit material being processed. Jason Moran according to LEAP was never tagged by any member. We are checking this against PURANA holdings.
- Enquiries continue regarding [REDACTED]. A partial transcript has been received from OPI regarding his conversation with OPI investigators. Petra investigators do not believe that there is sufficient in the material to warrant his arrest for Threats to kill or gain sufficient evidence for a search warrant. This has caused some angst at the Clan Lab Squad. To anyone who

- "Cell Dumps" for Telstra and Vodaphone have been ordered in an attempt to find out if there was any contact between her and Adam Ahmed on the morning of the 16th of May 2004 (Date of Hodson murders). We are still waiting for these dumps. It is likely that Vodaphone will be the carrier for both phones and that this "dump" will take some weeks to recover.
