2. I make this statement in the belief that the information I provide to the police cannot be used against me in any future court proceedings.

4. I have previously made a short statement in relation to visiting at 'The Grove Café' 153 Sydney Road Brunswick at 8.26 pm and meeting with Horty and Milad Mokbel. During this statement I discussed receiving a duo condenser from Milad Mokbel, delivered by Habib Mokbel. I make this statement providing a more detailed account of this event.
5. I have known Habib Mokbel for the past 6 years. He is related to Tony, Milad, Horty and Kabalan Mokbel. I was introduced to Habib at the Mokbel family home in [REDACTED] Brunswick in 2001. Since then I have seen Habib on numerous occasions at functions and visits to the family home. He lives in Rennie Street, Brunswick with his mum. On occasions Milad has used Habib in the past to tell me to come and speak to Milad when Milad couldn't reach me on the phone.
6. On this day, [REDACTED] 2006, I was walking with Milad Mokbel in the streets surrounding the café. We were in Norman Street, I think it was number [REDACTED] when Milad walked me to the front door. He knocked on the door which was answered by a Lebanese male. Milad asked this male to get Habib. I knew Habib Mokbel was at the house because his car, a green Toyota Camry sedan, was parked in the street at the front of this house.


7. Habib walked back with me and Milad to the street pathway. I heard Milad tell Habib to go home and get the duo-condenser. Habib then got into his car and drove away. I know Habib's house in Rennie street is the next street up. I had previously ordered a duo condenser from Milad.

8. Milad and I continued to walk the street and discuss other drug related matters. We were away from this house for about 10 to 15 minutes, until we returned to Norman Street. We went back to the same house and I noticed that Habib's car had returned. We again knocked on the door to the house which was answered by Habib. All three of us walked to his car. He then opened his car door and removed a cardboard box containing a glass duo condenser from the back seat. Habib then asked me to have a smell of his car. The strong smell of P2P was in his car. It appeared to be coming from the front passenger seat area. Habib and Milad both laughed at my reaction to the smell. I advised Habib to sell the car.

9. The three of us then walked towards Sydney Road. Habib was carrying the box. ~~The car I was driving was parked in Norman Street near the corner of Sydney Road. My car was open and Habib opened the back seat door and placed the box containing the duo-condenser on the back seat. Habib then closed the door and walked off towards the house in Norman Street. Milad and I returned to the coffee shop.~~

Mr Cooper [redacted] handed this box containing the duo-condenser to police.
