

Mr Cooper

States:-

1. My full name is ^{Mr Cooper} I am ^{P11} years of age
2. I make this statement in the belief that the information I provide to the police cannot be used against me in any future court proceedings.
3. In mid 2005 I was provided with a list from Horty Mokbel. This occurred at the Grove Coffee Shop. It was a list containing 80 different chemicals that could be obtained from a friend of Horty's as he knew someone who worked in the delivering of these chemicals for a chemical company. This list did not have the name of the chemical company, only a computer printout of the names of various chemicals in two columns. Horty asked me if any of these chemicals were of any value to us, by this I knew he meant in the manufacture of amphetamine. I went to the bar and asked [REDACTED] for a highlighter, which I used to highlight chemicals that were of use to us. The chemicals I highlighted were sulphuric acid, caustic soda, mono ethylamine, hydrochloric acid, ammonium chloride, and formaldehyde. Beside these I wrote the quantities which I thought would be obtainable. I then handed the list back to Horty and wished him good luck.
4. Three months later on entering the coffee shop to retrieve some money from Horty for a previous deal, he told me to take a key. He handed me a key to a van, which he told me was parked in [REDACTED], Brunswick, approximately 100 metres from the corner of [REDACTED]. Horty told me that all the things I had asked for on the list were now in this van and waiting for me or someone to pick it up and store them. At such short notice I had no-one to move the van and store it safely, so I picked up the van myself and drove it to the house at [REDACTED] Avondale Heights. When I returned to [REDACTED] I found that most of the chemicals were wrong. The ones that were right, the mono ethyl amine and the



sulphuric acid I stored at Steve Cvetanovski's mother's house, as it was close by. I didn't speak to Steve or his mother about this, until later.

5. The rest of the chemicals were wrong and I was concerned as the van was filled with ammonium nitrate, a fertiliser used in the making of bombs. This concerned me greatly as I already had enough to worry about. I went back to the coffee shop and had an argument with Horty over my concern for how wrong they had gotten it. I told him I wanted the van and the ammonium nitrate out of my house as soon as possible. Horty then told me to calm down and he would take care of it in the morning. He then mentioned that Tony Bayeh had stuffed up again.
6. The next morning Tony Bayeh and Horty Mokbel picked up the van from my garage at 9 am. Tony Bayeh drove off in the van with the unwanted chemicals still in the back of the van, and I never saw it again.
7. The chemicals I left at Steve's mother's house, I never used. I just left them there. Later that day the van was picked up, I had a discussion with Steve and told him that I had left the chemicals in the garage of his mother's home. He looked surprised and asked if anybody saw me. I told him 'no', and we agreed that I would move them to Preston later that week. But this never happened as I was too busy. We never spoke about them again.
