"Alls this now causes for me is huge heartache and grief. Since December when I was arrested my life has been fuckin' turned into shit. I was charged with offences that just fuckin' don't exit and I was locked up by people that had an agenda. I believe it was a malicious prosecution what was done to me and charged with offences that they knew would put me inside, a police member for nearly 16 years, put in with, you know, in the gaol cells with criminals that I'd worked on. Treated like a dog. And when I got the Brief of Evidence and I read it knowing full well that there was no God damned evidence because I had nothing to do with what they charged with me either, it just reeks of politism. People in this ESD for an agenda, for promotion, whatever it happened to be it was just a disgrace. I've been treated completely and utterly, um, in a whole different sense to than any other person would be treated in the street. Any civilian would not be in the position I'm in because the charges would have never been approved. It's just ridiculous. I've had to live with that and I've been able to live with that with the, as I've said to you earlier Charlie, putting, trying to put it behind me. Okay, I've got the court case coming up in October - a committal. I was very confidence initially that I wouldn't even be committed but magistrates are very loathe to, um, throw them out of a committal. So I've sort of come to grips with the fact that, yes, I'll be going to trial on this absolute trumped up crap. Um, but knowing full well no jury in the land, no person that understands the law, could even contemplate that I had anything to do with this or had any involvement in it. So having that in mind I've started to build my life back up again, not that you can ever build your reputation back they've destroyed that. The media and the Police Department did a very good job of that. Um, build my life up to a point where I've been, my only fuckin' focus has been on clearing my name, vindicating myself, and then the next step was getting back into the employment that I love which is the policing. You know, as much as the Chief Commissioner comes on the news or in the papers and says she's losing confidence in members and wants the power to sack. You know, I can't wait to sit in front of the Chief Commissioner one day and say, well how do you reckon my confidence is in, in this department when they've treated me like this? But I'm, you know, letting my heart, this is all I've ever done, this is policing. I've been policing all my life and it's, that's what I wanted to be doing. And now this is just gunna completely and utterly fuck really turn my life upside down again this. I had nothing to do with his death. You know, I really liked Terry HODSON, he was a, we became, we formed relationship. They are a very dangerous relationship to be involved in - informers."

He'd been informing on some very major criminals around Melbourne and also interstate, it doesn't just stop here in Melbourne. Um, after this incident in September where Terrence, um, was arrested and then turned informer and making statements against myself and MIECHEL and, he's also made statements against other major drug dealers now through the Ethical Standards Department. Um, look I've been in this game, I've worked at Homicide, you know, he's got a lot of enemies out there. Because once, once it became apparent that he has been informer, and I went to great lengths in the time that I was handling him to protect his identity, and his identity became known. Like solicitors sitting in court would be whispering in your ear, we know who your informer is, and to the point where they say, ya know, I know it's Terrence HODSON, ya know, and you'd be just, you know, not even answering and trying to, ya know, keep that wall up and keep him protected. You know, I had to change the way that we worked, we operated with Terry because he was being overly used, ya know, and it was just becoming too apparent. I mean every body that he dealt with was ending up locked up."
