Meaning of "document" or "documentation"

Where a request is made in this schedule for the production of a "document" and/or "documentation" that request is to be read as requiring production of the item in whatever form it might take and this includes but is not restricted to:

- (c) any item that has been created, transmitted or stored electronically;
- (d) emails and attachments;
- (e) any photograph;
- (f) C.D.'s, audio cassettes, disc tape, sound tape or other device in which sounds or other data (not being visual images) are embodied so as to be capable (with or without the aid of some other equipment) of being reproduced therefrom as well as any transcripts relating to any such recordings;
- (g) any video tapes, DVD's, any film, negative, tape or other device in which one or more visual images are embodied so as to be capable (with or without the aid of some other equipment) of being reproduced therefrom as well as any transcripts relating to any such recordings;
- (h) anything whatsoever on which is marked any words figures letters or symbols which are capable of carrying a definite meaning to a person conversant with them and, where applicable, drafts of any such documents.

- 12. All diary entries, day book entries, notes, information reports, briefing reports (whether in written or electronic form) made by any member of Victoria Police during the course of the investigation into the death of Terence Hodson.
- 13. All audio tapes, video tapes, information reports, notes, transcripts, diary entries, day book entries and all other documents (whether in written or electronic form) concerning any discussion, interview, debriefing or conversation with:
 - i. Any witness in this investigation;

- ii. Any person who would or might be called as a witness for the Prosecution in this investigation;
- iii. Any person suspected of or investigated in relation to the commission of an offence or offences, being the subject of this investigation.
- All listening device, telephone intercept, and surveillance logs regarding Paul Noel Dale.

If you are required to give evidence, you must attend at the hearing.

If you fail to attend the hearing or give evidence in accordance with this document a Warrant for your arrest may be issued.

You may produce this Summons and the documents or things referred to above to the Registrar of the Magistrates' Court at Melbourne by hand or by post, in either case so that the Registrar receives them not later than two (2) days (excluding Saturdays, Sundays or other holidays) before the date on which you are required to attend.
