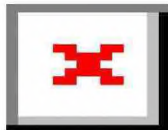

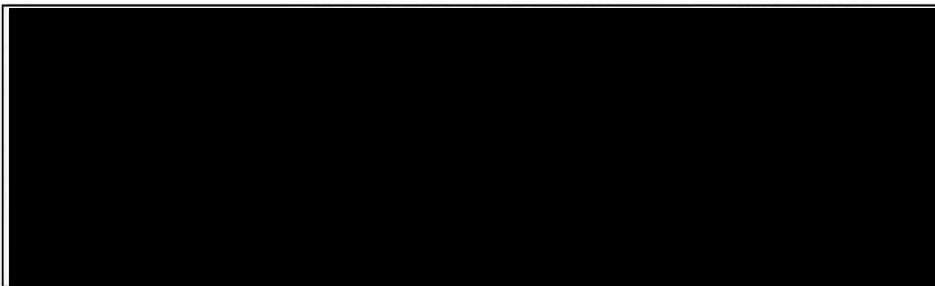

IT WAS almost an ordinary Saturday morning for Nicola Gobbo in 2004. The defence lawyer had slept in after a long week in court at the height of Melbourne's gangland war. But this weekend she had a headache she couldn't shake.

"I took some Panadol and it didn't go away. I took some Nurofen and it didn't go away, and then the phone rang," she recalls. "I knew who it was and I knew what I wanted to say, but not a word came out. I ended up in tears, hysterical because I didn't know what was going on."

Without realising it Ms Gobbo, then 31, was having a stroke.

With no voice to talk to a 000 operator, she sent a text message to a friend calling for help.

Making it to the emergency department of the Epworth, Ms Gobbo then passed out.

"I remember waking up to a neurologist saying 'my name is such and such and unfortunately you've had a stroke.' He said 'I understand you're a barrister, I hope you will be able to speak again.'"

"It was so terrifying. I had no idea what a stroke meant, what had caused it and what it was going to mean for me."

After fearing the worst, Ms Gobbo slowly regained her ability to speak over the following week. Aside from paralysis in one side of her face and temporary damage to the part of her brain that controls speech, she has not suffered any other permanent damage.

But what has frightened Ms Gobbo most was the lack of any warning. "I thought strokes only happened to old people and that it had something to do with high blood pressure or high cholesterol," she said. "I didn't have anything wrong with me except for high levels of stress."

Gobbo, whose long term clients include Mick Gatto and drug lord Tony Mokbel, is telling her story in the hope that it will help others recognize the signs.

A recent survey of 2500 Australians over 40 showed 15% did not know any signs of stroke, which include facial and arm weakness and speech difficulties. If people recognise the signs, getting to hospital can be the difference between life and death, the Stroke Foundation says.

While Ms Gobbo has quietly made changes to her life over the past four years, not a day goes by when she does not think about what happened in 2004.

"I still speak every morning when I wake up to check I'm OK. It's something that will probably stay with me forever," she says.
